

# Sliver Shadow (SSC) Promoter Program Terms & Conditions

## 1. Introduction

- Use fraudulent means to generate referrals.
- Violate data privacy regulations.

#### **7. Rewards & Commission Structure**

- Promoters will earn commissions based on successful referrals and sales.
- Bonuses may be offered based on performance milestones.

- Payment will be made in SSC tokens or designated cryptocurrencies.
- SSC reserves the right to adjust the commission structure with notice.
- Promoters must have at least **5 successful referrals** before they can withdraw their commission.
- Promoter levels will be determined based on withdrawals:
  - **Basic Promoter:** If you withdraw commission from 5-10 successful referrals ; **45% in USD, 55% in SSC**
  - **Advanced Promoter:** If you withdraw commission from 10-20 successful referrals; **55% in USD, 75% in SSC**
  - **Elite Promoter:** If you withdraw commission from 25+ successful referrals; **65% in USD, 135% in SSC**
- Withdrawals may take **7-14 days** for verification and processing.

## 8. Payment & Payout Terms

- Payments will be processed monthly, subject to a minimum payout threshold.
- Promoters must provide accurate wallet details for payments.
- SSC is not responsible for losses due to incorrect payment details.

## 9. Compliance & Legal Requirements

- Promoters must comply with all applicable laws, including anti-money laundering (AML) and Know Your Customer (KYC) regulations.
- Failure to comply may result in immediate termination from the program.
